Primer 7E is a one part high performance chemically active, non-toxic liquid for brush application to prime all concrete, stone, brickwork, timber and unglazed edges of ceramic tiles.

Advantages

Application

Apply one thin coat by using a clean dry brush. Avoid over application of primer causing puddles in the bottom of the joint. The mixed sealant must be applied when the primer becomes dry to touch (typically between 10 - 20 minutes after application @27°C).

Clean equipment immediately after use with Fosroc Solvent 102.
